All praise is due to Allah (SWT), and peace & blessing on his noble Messengers (AS), in particular, on the last of them all the blessed Prophet Muhammad (SAAW).

As the attention of the world, including Pakistan, has been focused on the current adverse economic and, to a certain extent, political developments that have engulfed the world, little consideration has been given to the "sudden" and "unexpected" resignation of the U.S. Ambassador to the UN, Nikki Haley.

While many think that this comes as part of the scheduled reshuffling in the Trump administration, we are devoting the editorial of this issue of Perspective to analyze the intrinsic and more profound reasons for this episode in context of its probable impact on the future designs of USA, Israel, India and the rest of the world.

We start with an obvious question:

Is Nimrata "Nikki" Haley, Netanyahu's 'candidate' as Israel makes plans to have AIPAC use its powerful organization to install her as the 46th President of the United States?

In a transparent move to infiltrate and control American politics, does the de facto head of AIPAC (the US Zionist Lobby in Washington), Binyamin Netanyahu have plans for the former US Ambassador to the U.N., Nikki Haley, to be a 'shoo-in' as the next American President, to succeed Trump?

Haley herself has denied any plans to seek the presidency.

Former United States Ambassador to Israel Dan Shapiro said that outgoing US Ambassador to the United Nations Nikki Haley intends to run for president, in an interview on Army Radio Wednesday morning.

"Nikki Haley does intend to run for president, if not in 2020, then in 2024," Shapiro said. "She earned enough of a reputation to outshine Trump and his scandals."

The human rights organization *CodePink* tweeted that the former U.S. Ambassador to the UN Nikki Haley, saying:

"(She) was probably the most pro-war, pro-imperialist high-ranking Trump official, and therefore the most beloved Trump official by the war-loving U.S. media. She held every conventional foreign policy view that has generated so much destruction."

The story began as the U.S. Ambassador to the United Nations Nikki Haley announced her resignation, but informed critics are raising their voices in the aftermath of the news to make sure nobody gets away with describing the outgoing diplomat

—who said she will serve in the position until the end of the year—as anything other than what she is: a sycophant for President Donald Trump and a horrible war-monger who used her powerful position to push a neoconservative foreign policy while undermining global goodwill, overtly attacking human rights, and making the world a more dangerous place.

While some news outlets and commenters ignored historical evidence as they attempted to frame Haley as a “moderate” voice in the Trump administration and Republicans applauded her “moral clarity,” progressive critics hit back hard against such blatantly false characterizations.

“Moderate?” exclaimed political commentator Amir Amini in a tweet responding the New York Times story about the resignation, adding:

“Haley spent every minute of her time at the UN threatening innocent nations w/ war, terror and literally bullying and trying to blackmail (and miserably failing) the entire [world] into supporting her agenda dictated by the military industrial complex.”

Analysts say that the price demanded by Netanyahu would be the formal US endorsement of its proposed annexation of the Occupied Territories of the West Bank, East Jerusalem and the Golan Heights to form the new official borders of the “Israeli state plus”, of course, a massive increase in US annual aid from the existing \$38 billion.

This would possibly also entail the implementation of the Likud agenda for a Greater Israel with Jerusalem as its capital city and the permanent expulsion of all indigenous Arabs to adjoining states.

The Indian American Nikki Randhawa met her husband Michael Haley when they were both undergraduates at Clemson University, South Carolina and Michael Haley subsequently worked at Exotica International, the clothing store founded by his mother-in-law, Raj Randhawa, before becoming a full-time federal military technician with the South Carolina Army National Guard in 2006.

Nikki’s father, Ajit Singh Randhawa, and her mother, Raj Kaur Randhawa, emigrated from Amritsar District, Punjab, India to USA in the late 60’s, hence suggesting a strong “Indian connection”.

More significantly, Michael Haley is an ardent admirer of US VP Mike Pence, the evangelical Christian sidekick of Donald Trump. The Evangelical Movement, (aka Christian Zionists of America), is a potent religious force numbering between 40 and 50 million (14% of population) who support the AIPAC lobby and the Likud Zionist agenda of Binyamin Netanyahu.

To have Nikki Haley installed as the next President of the United States of America would be the greatest coup of any Israeli government since its establishment in 1948, but would provoke an instability in the Middle East.

As for the United States. Is it really possible that the Israeli tail would have the chutzpah and the power to wag the American dog? In the light of our considered experience of the American-Israeli-Indian relations, and their designs for the Muslim Ummah in the future, particularly the Middle East and Pakistan, the answer would be *“Highly Likely”!*

**Press Releases issued by Tanzeem-e-Islami****Date: 12 October 2018****Lahore (PR): “The news being heard regarding amendment in the blasphemy laws are a matter of immense concern.”**

This was said by the Ameer of Tanzeem-e-Islami, **Hafiz Aakif Saeed**, in a statement. The Ameer remarked that it would be a colossal mistake on the part of the government if there was any truth in the rumored news. Even an attempt to make amendment of any sort in the blasphemy laws would enormously hurt the sentiments of Muslims and it would become virtually impossible for the government to control the ensuing anger and resentment of the masses, he added.

Therefore, he advised, that the government ought to refrain from making any such effort that would encourage those who disbelieved in the Finality of Prophethood (of Prophet Muhammad SAAW) or those who resorted to blasphemy against the Holy Prophet (SAAW).

While commenting on the reply given by the Crown Prince of Saudi Arabia, Mohammed bin Salman, in response to the statement of the U.S. President, the Ameer called it “welcoming, despite being mild” and noted that the rebuttal was reasonably sufficient, as it had been delivered by a “weak” country to a “strong” country.

However, the Ameer added, it is our considered opinion that if the Saudi Crown Prince wants to become genuinely free from the dictation of global powers, then he should make efforts to gain the benevolence of Allah (SWT) by implementing Islam in its totality in his country, in which case Allah’s (SWT) Divine help would most certainly be there to aid him. The Ameer noted that the Saudi Crown Prince ought to initiate that process (towards the genuine “right path”), as Makkah and Madinah were rightfully considered the Centers of Islam.

Establishment of the Islamic System of Collective Social Justice and Welfare in Saudi Arabia would encourage other Muslim countries too, the Ameer concluded.

**Date: 5 October 2018****Lahore (PR): “The Foreign Minister’s address in the United Nations General Assembly (UNGA) in Urdu is praiseworthy.”**

This was said by the Ameer of Tanzeem-e-Islami, **Hafiz Aakif Saeed**, in a statement. The Ameer demanded that the ruling of the Supreme Court of Pakistan regarding Urdu be implemented by the government by giving it the status as the official language of the state of Pakistan. The Ameer noted that the Foreign Minister of Pakistan had unmasked and exposed the state and non-state terrorism being perpetrated by India, on the International forum. He added that who does not know that India was the mastermind behind the mass-slaughter of innocent children in Peshawar and also the terrorist attack in *Mastung* in which hundreds of innocent people were martyred. The Ameer remarked that all such incidents were proof that, in fact, India was directly responsible for promoting and carrying out terrorist activities itself and then had the audacity of putting the blame on Pakistan as a scapegoat.

The Ameer said that the world should accept Pakistan’s account regarding the “proposed” competition of blasphemous caricatures in Holland that any and all attitudes of that kind amounted to “hate speech” which ought to be dealt with according to the International Laws governing such crimes. The Ameer added that the demand made by Pakistan at the UNGA to release *Dr. Aafia Siddiqui* was also completely justified.

While commenting on the statement given by the U.S. President, Donald Trump, in which he had said that the Saudi Government cannot last for two weeks without our (American) support, the Ameer said that such statement coming from the President of USA was, in fact, a mockery of the rulers of Saudi Arabia and a matter of great shame for the entire Muslim Ummah.

The Ameer stated that in our considered opinion a strong response and condemnation ought to be sent to the U.S. not only by the Saudi rulers but the entire Muslim world. The Ameer concluded by lamenting that the rulers of Saudi Arabia had resorted to a “mysterious silence” regarding the matter, to date.
